MEMBERSHIP CATEGORIES

Renewal Fees

Fees paid before September 1st will be discounted by \$20

Flying Members - \$280 (\$260 Before September 1)

Persons over 18 years of age. All have voting, club bar, club facilities and flying rights.

Spouse of flying Member - \$85 (\$65 Before September 1)

Family Members - \$510 (\$490 Before September 1)

Up to a Maximum of two adults cohabitating as spouses either de jure or de facto and their dependent children up to 18 years of age, such adults to be called 'Family Members'. All adult 'Family Members' have voting, club bar, club facilities, and flying rights. 'Supplementary Family Members' have club facilities and flying, but no bar or voting rights.

Observer/Social Members - \$85 (\$65 Before September 1)

Spouse of Observer/Social Member - \$85 (\$65 Before September 1)

Persons over 18 years of age. 'Observer Members' have bar and social rights, but no flying or voting rights.

Junior Flying Members - \$100.00 (\$80 Before September 1)

Persons under the age of 18 years. 'Junior Members' have club facilities and flying rights, but no club bar or voting rights.
